2026 UEFA Youth League™ Final Tournament Ticketing Terms and Conditions for Football Scouts

<p>Identity of the Data Controller</p>	<p>Union des Association Européennes de Football (UEFA), UEFA Club Competitions SA (trading as UC3) (“UC3”) and UEFA Events SA (“UEFA Parties”), whose offices are located at Route de Genève 46, 1260 Nyon 2, Switzerland, acting as joint controllers, via the Football Administration and Management Environment (FAME) platform in accordance with the 2026 UEFA Youth League™ Final Tournament Ticketing Terms and Conditions for Football Scouts (the “Terms and Conditions”).</p> <p>UEFA is responsible for the processing activities related to the Tournament. UC3 is the exclusive entity responsible for the exploitation of the commercial rights, including the sales of Tickets, in respect of the Tournament. LS VAUD FOOT SA has been appointed as the seller of the Tickets for the Tournament on behalf of UC3. UEFA Events SA carries out certain operational tasks in relation to the Tournament.</p> <p>Capitalised terms used but not defined in this Privacy Notification are defined in the Terms and Conditions in the context of which this Privacy Notification must be taken note of and read in the ticket application process.</p>
<p>Categories of personal data</p>	<p><u>When applying for Tickets for the Tournament</u>, you are requested to provide the following personal data:</p> <ul style="list-style-type: none"> • first name(s) and surname • date of birth • organisation you represent • phone number • e-mail address • scout identification document <p><u>If requested by UEFA Parties</u>, you will provide the following personal data for Tickets allocated to your Guest:</p> <ul style="list-style-type: none"> • first name(s) and surname <p><u>When attending the Match</u>, your voice, image and likeness may be recorded during your time in the Stadium (“Recordings”).</p>
<p>Purposes of the processing</p>	<p>The personal data are collected and processed:</p> <ol style="list-style-type: none"> (i) for the purposes of handling your Application Form and providing you with Tickets for the Tournament (if your application is successful). (ii) for the purposes of the performance, the management and the follow-up of any purchase contract entered into with UEFA Parties.

	<p>(iii) for the purposes of any relevant safety, security and sanitary measures related to the Tournament.</p> <p>The Recordings are also used by UEFA for the purposes of public reporting and promotion of the Tournament.</p>
<p>Legal basis</p>	<p>The personal data are processed on the basis that such processing is necessary in order to process your Application Form in accordance with the Terms and Conditions – including for determining your eligibility – and entering into a contract with UEFA regarding Tickets for the Tournament (if your application is successful).</p> <ul style="list-style-type: none"> ➤ Legal basis for the data processing is Article 6 (1) lit. b of the GDPR and Article 31 (2) (a) of the FADP (performance of a contract). <p>The personal data are processed on the basis that such processing is necessary for the purpose of the legitimate interest of guaranteeing an effective security system and a safe environment inside and around the Stadium.</p> <p>The use of the Recordings is also necessary for the purpose of the legitimate interest of public reporting and promotion of the Tournament in general and the respective Match.</p> <ul style="list-style-type: none"> ➤ Legal basis for the data processing is Article 6 (1) lit. f of the GDPR and Article 31 (1) of the FADP (legitimate interest).
<p>Failure to provide the data</p>	<p>You are free to apply for Tickets and provide your personal data to UEFA. If you do not provide personal data, you may not apply for, purchase and/or be allocated Tickets for the Tournament.</p>
<p>Categories of recipients</p>	<p>You understand that your personal data will be available to UEFA Parties</p> <p>You further understand that your personal data (first name, last name, email and club/organisation) and the personal data of your Guest will be transferred to LS VAUD FOOT SA in accordance with their own privacy policy for the purpose of distributing Tickets by virtue of “print@home” e-tickets.</p> <p>Technical service providers may access certain personal data for the sole purpose of (i) maintaining the security and performance of FAME, and (ii) issuing and distributing Tickets, acting as data processor(s) in this context.</p> <p>Third parties authorised by UEFA Parties in each case (e.g., broadcasting, press) may process, exploit and publicly reproduce the Recordings for the purposes of public reporting and promotion of the Tournament in general and the respective Match.</p> <p>LS VAUD FOOT SA, the Stadium Owner, the stadium security and access service providers and any such other providers which help to organise the Tournament and maintain safety and security (including in relation to sanitary measures) may access certain personal data for the purposes of providing their services.</p> <p>The transfer of personal data to the relevant public authorities, based on legal provisions and obligations, for the purpose of safety, security and</p>

	<p>sanitary measures and law enforcement related to the Tournament, is reserved.</p>
Onward transfer	<p>UEFA will not, in principle, transfer your personal data to countries outside of the European Economic Area (EEA) with the exception of data processing within Switzerland by UEFA Parties or any service providers identified above. The EU Commission has decided that Switzerland ensures an adequate level of data protection (Article 45 of the GDPR).</p> <p>When the recipients identified above are located in countries which do not ensure an adequate level of protection within the meaning of applicable data protection laws, in particular, according to Article 44 et seq. of the GDPR, UEFA Parties (i) have put in place European Commission approved standard contractual clauses to protect your personal data and/or (ii) will rely on your consent (where permitted by law).</p> <p>To learn more about those safeguards, please contact us at: privacy@uefa.ch.</p>
Your rights	<p>You may request deletion, access or update your personal data by contacting us at: UYLFscoutsticketing@uefa.ch.</p> <p>In addition, you have certain rights under Chapter III of the GDPR, depending on the legal basis and the purpose of the processing, in particular the right of access (Article 15 of the GDPR) and the rights to rectification (Article 16 of the GDPR), erasure (Article 17 of the GDPR), restriction of processing (Article 18 of the GDPR), and data portability (Article 20 of the GDPR), as well as the right to object (Article 21 of the GDPR).</p> <p>The data privacy team can be contacted at: privacy@uefa.ch.</p> <p>You have also the right to lodge a complaint with your local Data Protection Supervisory Authority and have the ability to seek to enforce their rights through a judicial remedy. Retention period	<p>The personal data is only collected and processed by UEFA Parties for no longer than is necessary for the purposes described above, unless the use of such personal data is further required for ongoing administrative or judicial proceedings relating to the Tournament or, where necessary, for preventing or detecting unlawful actions or due to statutory retention obligations.</p>
Personal data obtained from others	<p>IF YOU SUBMIT PERSONAL DATA ON BEHALF OF OR FOR OTHERS WHEN APPLYING FOR TICKETS, YOU CONFIRM HAVING A LAWFUL BASIS FOR THE SUBMISSION (E.G., CONSENT OR CONTRACT) AND HAVING INFORMED THEM OF THE CONTENT OF THIS PRIVACY NOTIFICATION PRIOR TO DATA CAPTURE. YOU ACCEPT THE RESPONSIBILITY OF INFORMING EACH PERSON OF THESE RULES AND PROCEDURES. UEFA PARTIES ARE ENTITLED TO REQUIRE AT ANY TIME EVIDENCE OF SUCH LAWFUL BASIS AND OF THE PROVISION OF SUCH INFORMATION.</p>
